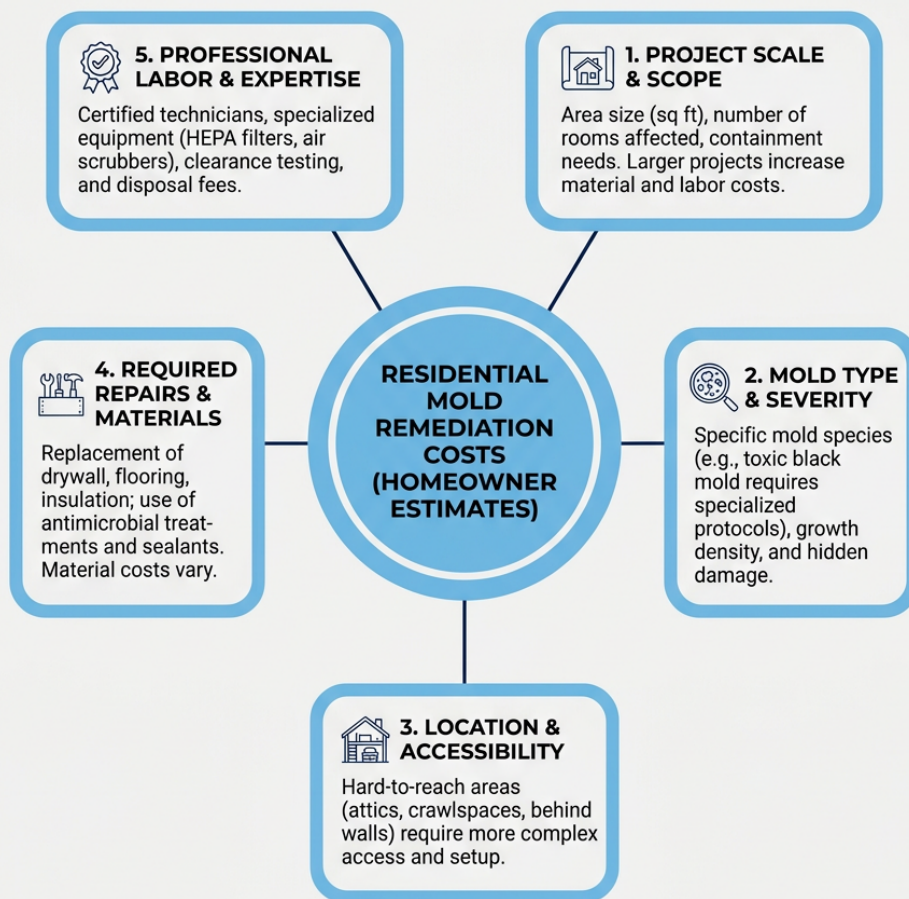
How does incomplete mold removal create compounding damage and escalated costs over time?
