As the jobs fall within the Party Wall Act, they have actually had to offer you a Notice informing you of the proposed works that will certainly occur. The proprietors of the party wall surface may share the prices of the structure job only if they confine on it (e.g. the neighbor chooses to use the garden wall astride the boundary for his expansion).
