

What Is the Anion Gap?

The **anion gap** is a calculated value that helps clinicians evaluate **acid-base balance** and detect possible causes of **metabolic acidosis**. It is derived from common **electrolytes** measured in a standard **electrolyte panel**, usually including **sodium**, **chloride**, and **serum bicarbonate**. Because routine blood chemistry does not measure every charged particle in the bloodstream, the anion gap estimates the difference between measured cations and measured anions, offering insight into **unmeasured anions**.

In these cases, the anion gap is a useful clue, but the diagnosis depends on prompt clinical evaluation and targeted testing.

Normal-gap patterns also matter. **Normal anion gap metabolic acidosis** often reflects gastrointestinal bicarbonate loss, renal tubular disorders, or the chloride-rich replacement of bicarbonate. 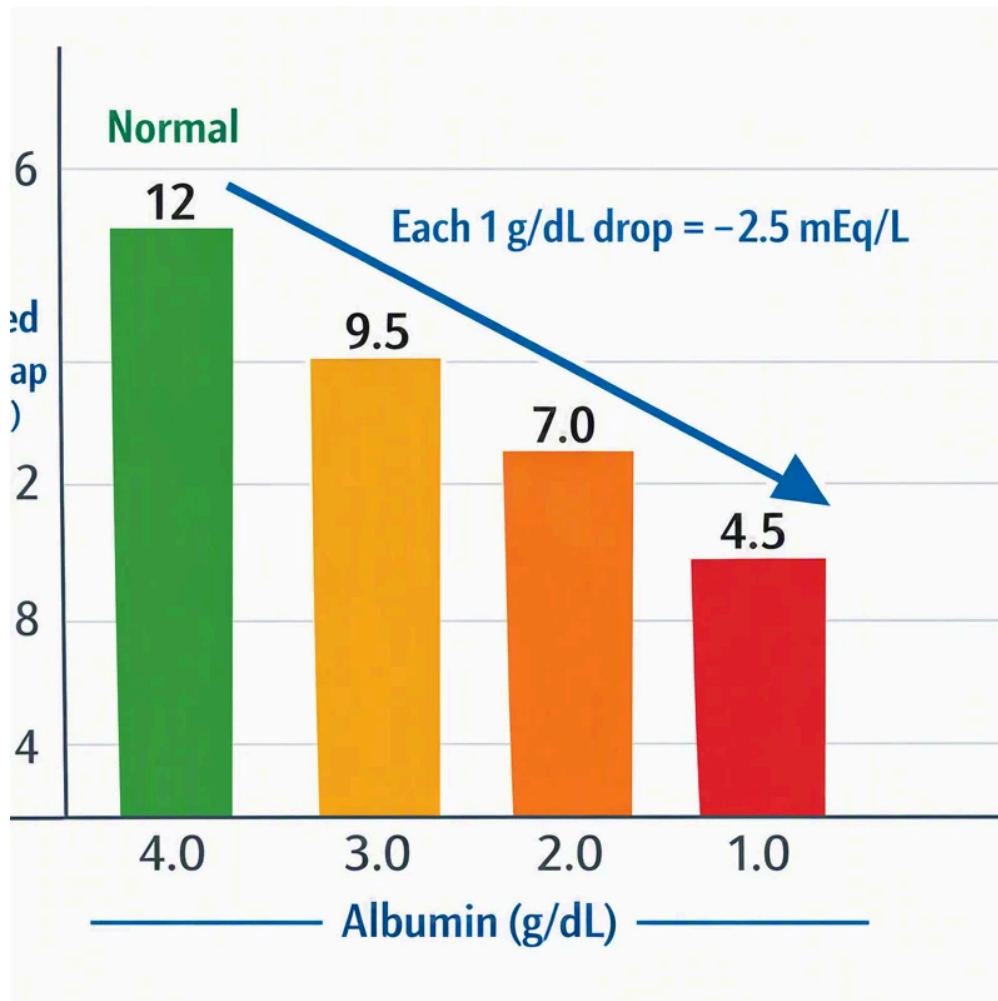
