Georgia handles a death case differently than most people expect. There are generally two separate claims. Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also thins out, especially when a company vehicle or a business is involved.
