

What the Anion Gap Evaluates

The **anion gap** is a computed measurement that assists clinicians in evaluating **acid-base balance** by contrasting the major measured **electrolytes** in blood. It is typically calculated from **sodium**, **chloride**, and **bicarbonate**, and it offers a fast way to look for unmeasured acids in the bloodstream. Most formulas use sodium, chloride, and bicarbonate, though some versions also account for potassium. That is why **clinical context** remains crucial. The anion gap can point to a problem, but it cannot tell you whether the cause is kidney injury, sepsis, diabetic ketoacidosis, ingestion, or another metabolic disorder. It is best used alongside the patient's symptoms, exam findings, and overall trajectory.

Additional Tests Used to Monitor Recovery

To assess whether therapy is actually helping, clinicians usually combine the anion gap with other tests. A **blood gas**, especially an **arterial blood gas**, can reveal pH, respiratory compensation, and the degree of acidemia. This aids determine whether the acid-base disturbance is getting better in a way that follows the anion gap trend.

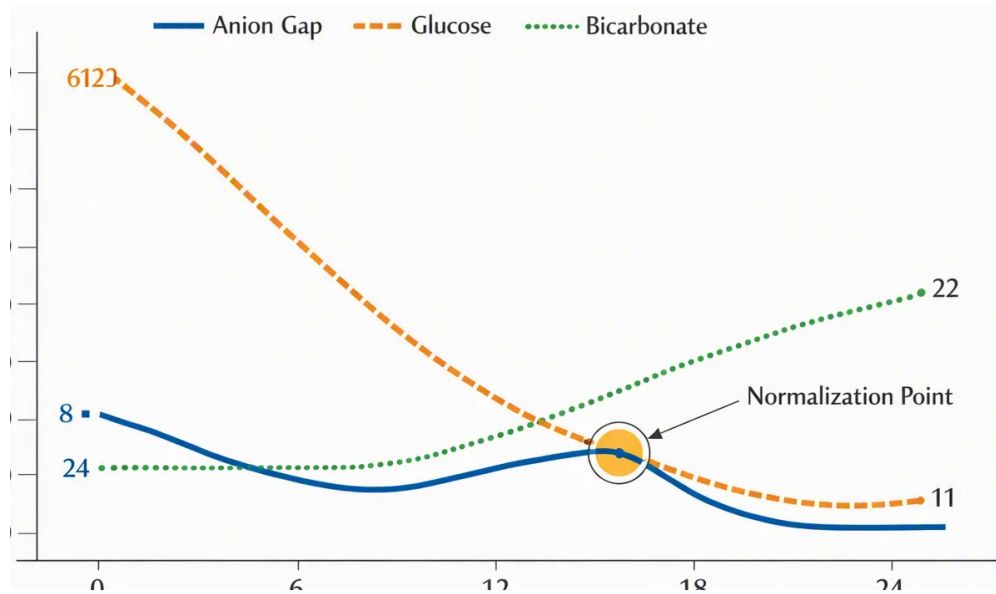
