

When a rider is hurt and were hit around Atlanta, the assumption is already working against you.

People arrive with a view already formed: that the rider was going too fast, was weaving through traffic, or took a risk a car driver would not.

Sometimes that is accurate. Usually the car turned left across a rider who had the right of way.

Injury severity cuts both ways. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
