

What the Anion Gap Measures

The **anion gap** is a calculated value that assists clinicians assess **electrolytes** and interpret **acid-base balance**. It is frequently used as part of the workup for **metabolic acidosis**, particularly when the cause is not immediately obvious. An **Anion Gap Calculator** is simply a tool that performs the calculation from the key laboratory values, but the result is only as useful as the data entered and the clinical context around it.

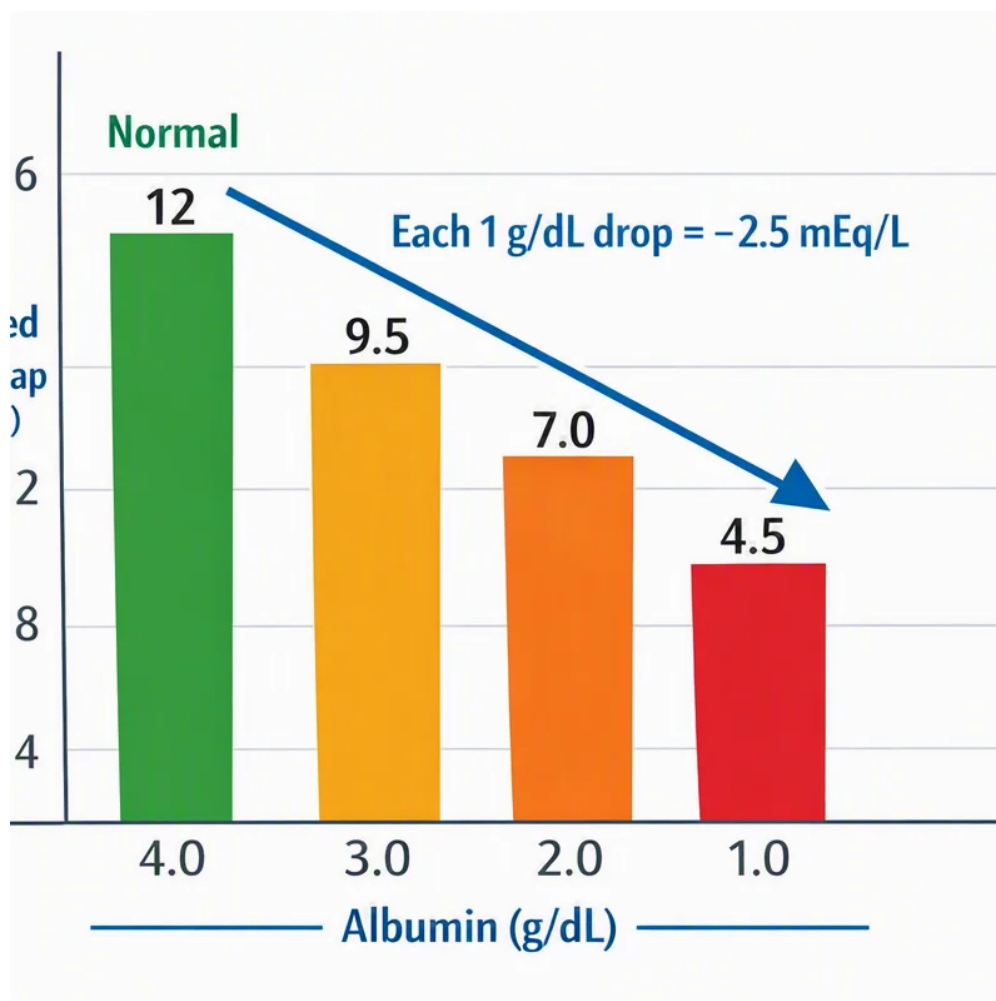
