

What the Anion Gap Shows

The **anion gap** is a calculated value used to measure **acid-base balance** in the body. It comes from an **electrolytes** blood test and shows the relationship between commonly measured ions, especially **sodium**, **chloride**, and **bicarbonate**. For **adult patients**, this number can offer helpful signs about an **acid-base disorder**, especially when **metabolic acidosis** is suspected.

Think of the anion gap as a lens into the difference between measured positive and negative charges in the blood. Because routine testing does not measure every charged particle, the result represents the amount of *unmeasured anions* that may be present. Typical Anion Gap Range in Adults

Does low albumin affect the anion gap result?
