

What is the anion gap?

The anion-gap value is a computed figure used to assist evaluate an acid–base imbalance from a basic electrolyte test panel. It [diarrhea NAGMA cause](#) looks at the main measured cations and anions in serum electrolytes, usually using sodium, chloride, and bicarbonate. In many cases, potassium may also be included, but the most common clinical formula focuses on sodium, chloride, and bicarbonate because potassium contributes less to routine interpretation.

Anion gap = Sodium - (Chloride + Bicarbonate)

Corrected anion gap = Measured anion gap + 2.5 mEq/L for each 1 g/dL albumin below normal

Renal failure is another notable example because reduced acid clearance can increase the anion gap. If albumin is low at the same time, the measured value may look less abnormal than it truly is. In such cases, a corrected anion gap can improve diagnostic accuracy and support further evaluation.

The corrected anion gap is helpful, but it is not definitive. One limitation is laboratory variation. Different analyzers, assay methods, and reporting conventions can affect sodium, chloride, bicarbonate, and albumin values. Small shifts in laboratory values may affect the calculated result.

Another limitation is that mixed acid-base disorders can complicate interpretation. For example, a patient may have metabolic acidosis and metabolic alkalosis at the same time. In that case, the anion gap alone may not fully capture the underlying physiology. The corrected anion gap helps, but it should not take the place of full clinical assessment.

Albumin level also matters because the formula assumes a standard relationship between albumin and the gap. That relationship may not hold perfectly in every patient. Severe illness, paraproteinemia, unmeasured ions, and unusual electrolyte patterns can all affect the final interpretation.

For that reason, clinicians should interpret the result in clinical context rather than treating the corrected number as absolute. The correction improves the estimate, but it does not eliminate uncertainty. The best use of the calculation is as part of a broader evaluation that includes symptoms, acid-base status, and the rest of the electrolyte panel.

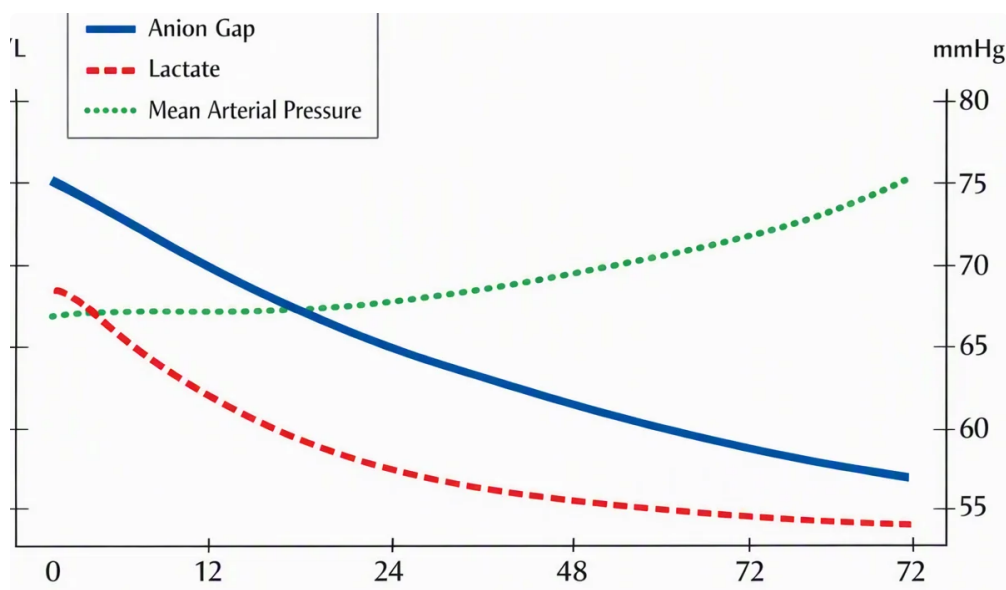
Example 1:

Measured anion gap = 10 mEq/L

Serum albumin concentration = 2.0 g/dL

Using a reference point of 4.0 g/dL, the albumin deficit is 2.0 g/dL.

Correction = $2.5 \times 2.0 = 5.0$ mEq/L



Corrected anion gap = 15 mEq/L

Meaning: The measured value looked normal, but the corrected anion gap suggests a possible high anion gap process. It is a classic example of how low albumin can hide metabolic acidosis.

Example 2:

Measured anion gap = 16 mEq/L

Serum albumin concentration = 3.0 g/dL

Albumin deficit = 1.0 g/dL

Correction = $2.5 \times 1.0 = 2.5$ mEq/L

Corrected anion gap = 18.5 mEq/L

Interpretation: The corrected value is more clearly elevated and supports evaluation for high anion gap metabolic acidosis.

Example 3:

Measured anion gap = 8 mEq/L

Serum albumin concentration = 1.5 g/dL

Albumin deficit = 2.5 g/dL

Correction = $2.5 \times 2.5 = 6.25$ mEq/L

Corrected anion gap = 14.25 mEq/L

Meaning: This result shifts from low-normal to potentially abnormal once hypoalbuminemia is considered. That change can materially affect diagnosis and management.
