

If you have been injured after a fall in the Atlanta area, the case turns on something most people do not expect. Proving the hazard existed is only the start.

Georgia law generally requires that the property owner knew about ***personal injury compensation lawyer*** the hazard, created it, or would have discovered it by inspecting the way a careful owner should.

This is the reason the first days matter so much. Camera footage is often overwritten within days, and once it is gone there is no way to show how long the hazard sat there.

Incident reports are written by the party you will be making a claim against, which affects what ends up in them. The store's own inspection records are just as important, since a written policy that was ignored says a great deal.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
