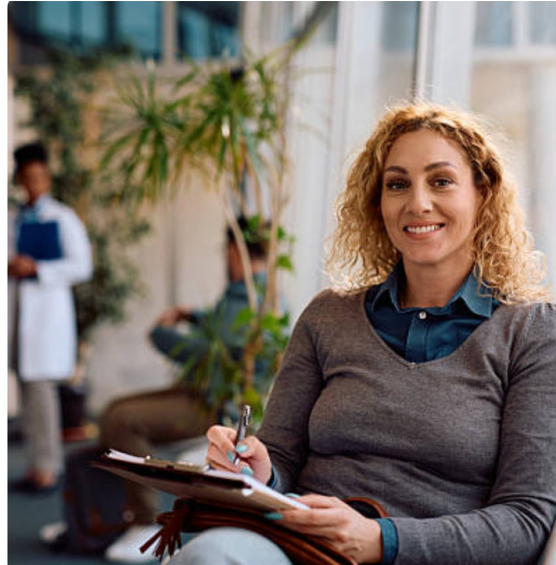
Add low-cost perks with high value

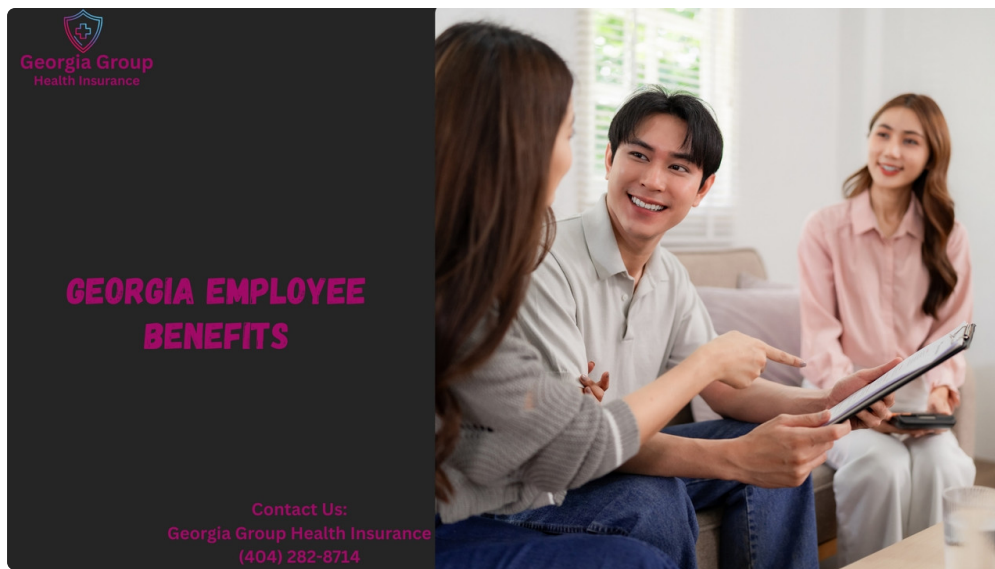
Perks worth considering
