

If you ride and a driver did not see you around Atlanta, there is a prior you have to overcome.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was weaving through traffic, or took a risk a car driver would not.

Sometimes that is accurate. Usually the car turned left across a rider who had the right of way.

The work is physical evidence, not story, since the story is doubted before it is told. Sight line analysis carry more weight than either version of events.

Injury severity cuts both ways. [truck accident lawyer](#) A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
