

If you were hurt in a fall in the Atlanta area, there is more to it than the hazard itself. The dangerous condition alone does not win the case.

Under Georgia law you generally have to show that the property owner knew about the hazard, caused it themselves, or would have discovered it by inspecting the way a careful owner should.

This is the reason the opening weeks decide these cases. Store video [car wreck attorney](#) is often overwritten within days, and without it you cannot establish how long the condition existed.

The report the store writes are written by the party you will be making a claim against, which shapes what they contain. The store's own inspection records matter just as much, because a policy nobody followed is its own kind of evidence.
