

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, usually when the [personal injury accident lawyer](#) bills arrive or an insurer calls.

Georgia law sets an order for who may bring that first claim. It generally begins with a surviving spouse, then children, then parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also disappears, especially when a company vehicle or a business is involved.
