The first step in any sound warranty verification procedure is gathering your paperwork. Locate your original purchase receipt, product manual, or warranty card—these documents contain the serial number and registration details needed to query the manufacturer's claims system. If you've misplaced the physical copies, contact the retailer where you purchased the dryer; most major appliance stores maintain digital purchase records. You can also check the manufacturer's website directly by entering your dryer's serial number, usually found inside the door frame or on the back panel.

Once you've verified your warranty is active, the next part of the claim sequence involves submitting proof of purchase and the serial number to the manufacturer. Most manufacturers now operate online claim portals where you upload your receipt image and provide your dryer's identification number. This documentation gating is a critical step—without proof of purchase tied to the serial number, the manufacturer won't process your claim, even if you're within the coverage window.

The claim sequence also requires you to describe the failure in detail. Does the dryer not heat? Is it making unusual noises? Is it failing to tumble?
