

If an electrical injury happened at work in Atlanta, several companies may share responsibility.

A site has an owner, a general contractor, the electrical subcontractor, sometimes the utility, occasionally an equipment maker, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it bars a suit against your employer. It does not stop a claim against another company that caused the danger.

That third party claim is usually where the real recovery sits, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
