

When someone is shocked or burned on a job site around Atlanta, the answer is rarely a single company.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a [truck accident attorney](#) claim against a third party whose conduct **truck accident lawyer** created the hazard.

That third party claim is usually where the real recovery sits, since comp covers none of the human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, and none of that is available just for the asking.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
