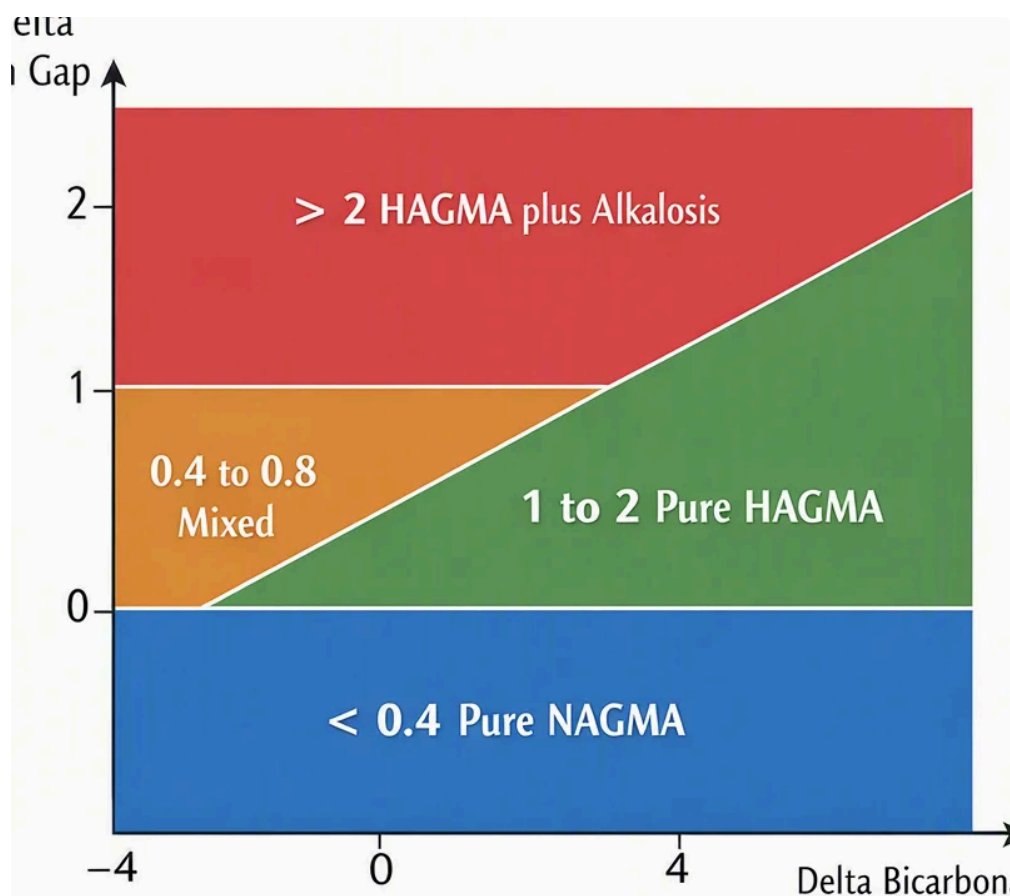




What the Anion Gap Measures

This **anion gap** is a practical way to interpret **serum electrolytes** and estimate whether unmeasured ions may be affecting **acid-base balance**.
