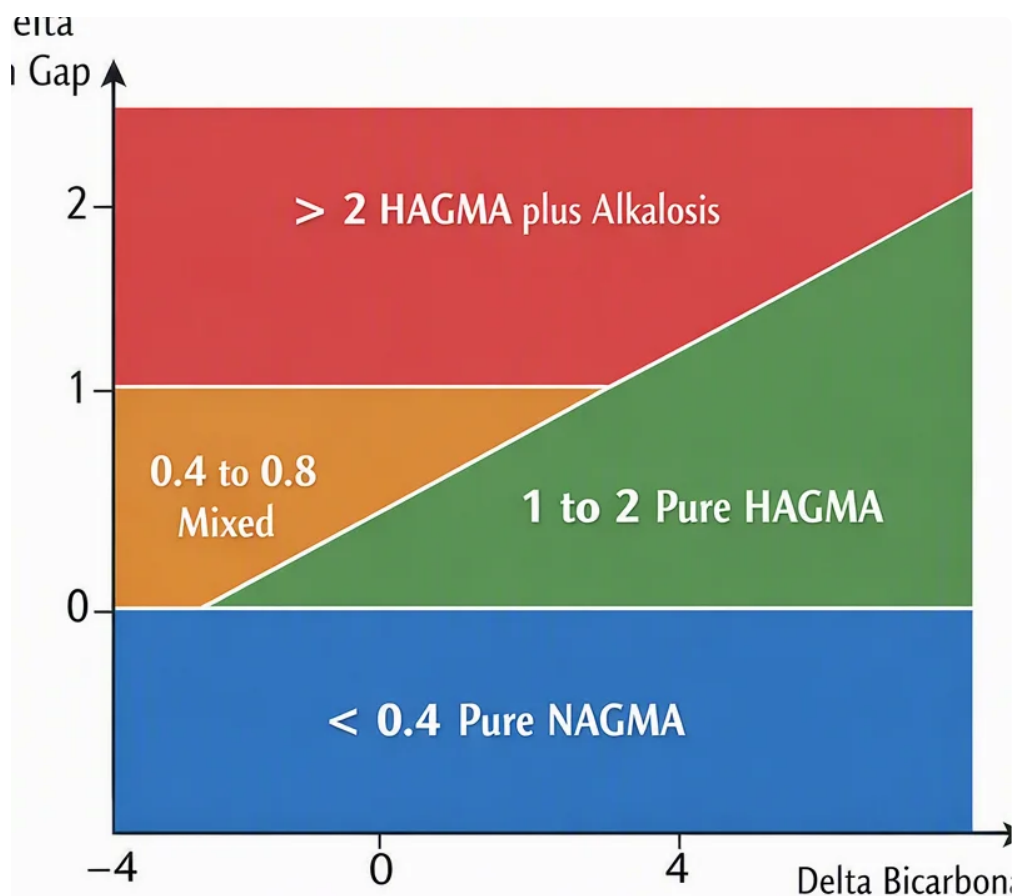




What is the anion gap?

The **anion gap** is a derived value from a **blood test** that is used to assess **acid-base balance** and suspected **electrolytes** imbalances. It is derived from common **blood chemistry** measurements, especially **sodium**, **chloride**, and **bicarbonate**, with **potassium** sometimes included depending on the **formula** used. How the anion gap is calculated

The standard formula for calculation is:

$$\text{Anion gap} = \text{Na} - \text{chloride} + \text{bicarbonate}$$

Certain methods include **potassium**, but most everyday calculations do not. When potassium is included, the formula becomes:

$$\text{Anion gap} = \text{sodium} + \text{potassium} - \text{chloride} + \text{bicarbonate}$$

In either version, the **serum sodium**, **chloride level**, and **bicarbonate** should be in the same measurement units, usually **mEq/L** or **mmol/L**. Because the calculation is based on a subtraction step, consistency is essential. Mixing units can change the apparent gap and skew the diagnostic picture.

For example, if the sodium is 140, chloride is 102, and bicarbonate is 24, the calculation would be:

$$140 - (102 + 24) = 14$$

That result can be interpreted against the expected **normal range** or **reference range** used by **anion gap in chronic kidney disease** the laboratory or the calculator. If potassium is included, the result would be slightly different, so users should always know which **formula** is being used by the **Anion Gap Calculator**.
