

What Means the Anion Gap?

The **anion gap** is a calculated value used to analyze **acid-base disorder** patterns, especially **metabolic acidosis**. It reflects the difference between the main measured cations and anions in a basic serum chemistry panel. In practice, the most common inputs are **serum sodium**, **serum chloride**, and **serum bicarbonate**.

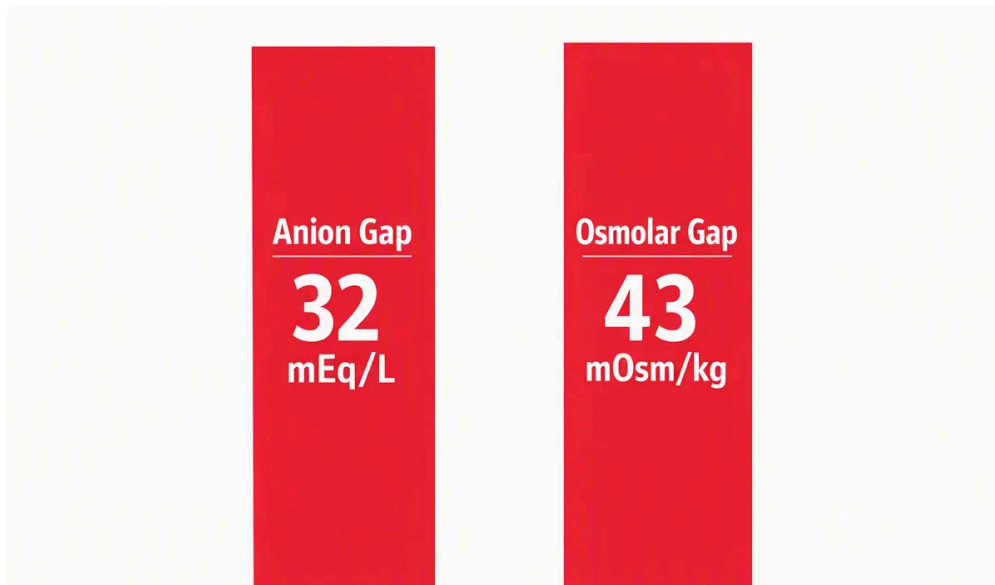
What Is the Osmolar Gap?

These tests are often used together because they provide distinct levels of information. A patient with metabolic acidosis and an elevated osmolar gap raises concern for a toxic ingestion, while a patient with elevated anion gap but normal osmolar gap may point more toward lactic acidosis, ketoacidosis, or renal failure.

The best use of either test depends on the clinical picture. They are not screening tests in isolation; they are specific pointers within a broader diagnostic process.

Frequent Causes of an Elevated Anion Gap

An elevated anion gap typically suggests the presence of extra acids or **unmeasured anions**. Some of the most common causes include:

- **lactic acidosis**

- **ketoacidosis**
- **renal failure**
- **salicylates**
