

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia handles a death case differently than most people expect. There are generally two separate claims. One belongs to the surviving family and covers what the law calls the full value of the life that was lost. The other belongs to the estate and covers things like the final medical bills, the funeral, and any conscious [car wreck claim lawyer](#) suffering before death.

Georgia law sets an order for who may bring that first claim. It generally begins with a surviving spouse, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some of them are shorter than the general rule. A claim against a government entity can require written notice far sooner than the filing deadline. Evidence also disappears, especially when a company vehicle or a business is involved.
