

A truck wreck is not a car wreck. A loaded tractor trailer can weigh many times what your car weighs, and the injuries are usually far worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene within hours, before you are out of the hospital. They begin building the company's side of the case right away.

More than one company can be responsible. The trucking company, a maintenance contractor, a freight broker, or whoever loaded the trailer can each share it. Each of those is its own question with its own evidence.
