

When a dog attack leaves someone hurt in the Atlanta area, Georgia works differently than people expect.

Some states hold the owner responsible no matter what. Georgia does not work that way. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

These records fade fast. County records and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.
