

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one eventually, usually when the bills arrive or an insurer calls.

Georgia treats a death case differently than people tend to assume. There are generally two separate claims. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. Who may bring the first claim follows an order set by statute. A surviving spouse generally comes first, then children, then <https://www.instapaper.com/read/2033633334> parents, and then the estate. When there is a surviving spouse and children, the law also sets a floor on the spouse's share.

Deadlines apply, and some are shorter than people expect. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also thins out, especially when a **atlanta personal injury attorney** company vehicle or a business is involved.
