

When buyers evaluate a specialty ingredient, they rarely start with the specification sheet alone. They start with signals. They want to know who is behind the product, how seriously the company treats quality, and whether the business looks built for long-term relationships rather than short-term transactions. For an ingredient as technical and application-sensitive as iron peptides, those signals matter even more.
