

A rideshare wreck raises a question a normal car crash does not: whose insurance [18-wheeler accident attorney](#) actually pays. The answer turns on what the app was doing when the crash happened.

If the app is off, it is an ordinary car wreck, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can be the difference between a modest policy and a substantial one, and the app data that establishes it belongs to the rideshare company.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each one can reach different policies.
