

If you ride and were hit in Georgia, the assumption is already working against you.

There is a built in bias in motorcycle claims: that the rider was going too fast, was weaving through traffic, or took [The original source](#) a risk a car driver would not.

Sometimes that is accurate. Frequently the driver simply did not see the motorcycle and turned across it.

The work is physical evidence, not story, because narrative starts at a disadvantage. Damage patterns do the arguing.

Injury severity cuts both ways. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
